Total 100 points Students intending to undertake combined honours in history and philosophy of science and another area of study should consult the honours coordinator about structuring their course. Honours and postgraduate diploma students may take up to two existing honours subjects offered by the Philosophy program towards their fourth-year studies in history and philosophy of science. Subjects from the following list will be approved automatically. Other subjects may be approved on a case-by-case basis. No more than three philosophy and/or philosophy of science subjects may be taken as part of history and philosophy of science honours.
