<b>Subject Overview:</b>	<p>The subject introduces the concepts of parks, reserves and wilderness areas and discusses the considerations for effective land management of these areas.</p> <p>On completion of this subject, students should:</p> <ul style="list-style-type: none"> <li># be aware of the recreational opportunity spectrum and its implications in managing recreational activities in the forest;</li> <li># understand the complexity of park management and the need for balance in making decisions about forest use;</li> <li># be aware of the development process and history of parks and wilderness areas;</li> <li># be aware of the policy and legislation relevant to the management of these areas; and</li> <li># understand the importance of extension, interpretation, education and enforcement in the effective management of parks and wilderness areas.</li> </ul> <p>The subject covers the areas of:</p> <ul style="list-style-type: none"> <li># history and development of National Park legislation and systems;</li> <li># policy, planning and management for National Parks;</li> <li># cultural and historic values in National Parks and extension and enforcement;</li> <li># recreation and park management; and</li> <li># interpretation techniques.</li> </ul>
