Subject Overview:	This subject examines various ways of knowing the environment. Students develop an understanding of the unprecedented transformation in the environment, the sciences, and in politics around environment and knowledge across the twentieth century. As part of their assessment students will study the knowledge practices of a particular environmental organisation becoming sensitised to historical, political and cultural influences on environmental knowledge.
Objectives:	Students who successfully complete this subject will <ul style="list-style-type: none"> # become aware of new understandings of knowledge that are developing in response to the perceived complexity of environmental knowledge # Become acquainted with theories and concepts that will enable them to think critically about characteristics that are required for efficacious environmental knowledge.
Assessment:	A research report of 5000 words 100 per cent (due at the end of the SWOT VAC).
Prescribed Texts:	A subject reader with key texts will be available from the bookshop.
