Course Overview:	The course provides nurses with the confidence and skill to provide the best possible health care for consumers. Masters prepared nurses will assume a major responsibility in developing new professional roles, devising new models of care and overseeing dynamic changes to practice. As clinically proficient and professionally articulate practitioners, graduates of the MANP will make their mark on the profession and on health care.
	The first year of study provides the opportunity for you to extend your nursing knowledge into an area of specialty practice. The second year of study focuses on advanced practice skills and knowledge, preparing you for leadership roles in practice and education and for extended clinical roles, with the option of preparation for Nurse Practitioner endorsement for appropriately qualified applicants.
	Enrolment in clinical components of the MANP is dependant on meeting the registration and clinical experience requirements outlined in the <u>Admission Requirements</u> (http://www.nursing.unimelb.edu.au/courses/SAP/admission.html) section. You must also have the support of your current employer to facilitate completion of specialty clinical competencies.

Course Structure & Available Subjects:	The course comprises 100 credit points of study in the first year and 100 credit points in the second year. In the first year, you will undertake a program of study identical to the Postgraduate Diploma in Nursing Practice or Postgraduate Diploma in Nursing. To enrol in subjects with clinical components you must meet the registration and clinical experience

requirements outlined in the Admission requirements section. You must also have the support of your current employer to facilitate completion of specialty clinical competencies. During the first year of study, you may take up to 12.5 points of subjects from other disciplines. In the second year, you can choose one of two pathways. Pathway 1 comprises 100 credit points of coursework subjects. Pathway 2 comprises 50 credit points of coursework subjects and a 50 credit point minor thesis. To achieve a specialisation award, assessment tasks completed in the second year must share the specialty focus of your first year studies. If you enrol in the generic program you can complete subjects to address areas of specialty practice not currently offered as specialty streams or you can combine subjects for a broader focus. In the second year you may also take up to 25 points of approved subjects offered in other disciplines. Please see the list of possible electives.

Subject Options:

Pathway 1 - coursework

Pathway 1 is ideal if you want to develop advanced practice skills and knowledge, and prepare for leadership roles in practice and education, and extended clinical roles.

Students are required to undertake at least one research subject, either NURS70002 or NURS90070 in their second year of study.

The remaining subjects can be selected from the listed elective subjects below.
