Entry Requirements:	<p>1 The Selection Committee will evaluate the applicant's ability to pursue successfully the course using the following criteria:</p> <ul style="list-style-type: none"><li># An undergraduate degree; or</li><li># a relevant TAFE or Higher Education Advanced Diploma or equivalent and 3 years full-time, relevant, documented professional work experience or equivalent; or</li><li># a relevant TAFE Diploma and 4.5 years full-time relevant, documented professional work experience, or equivalent; or</li><li># 6 years full time relevant, documented professional work experience, including at least 3 years in a demonstrated supervisory role.</li></ul> <p>2 The Selection Committee may conduct interviews and tests and may call for referee reports or employer references to elucidate any of the matters referred to above.</p>
