Workplace accredited clinical competency achievement in the context of full unrestricted registration with the Nurses Board of Victoria (NBV) and employment is mandated for the Postgraduate Diploma in Nursing Practice.  |  |  |
|  | Depending on subject selection the award is available as a generic qualification or with bracketed specialization to acknowledge the nursing specialty that is the focus of the student's studies.  |  |  |

| Learning Outcomes:                     | Overall the Postgraduate Diploma in Nursing Practice aims to provide the opportunity for nurses to extend their nursing knowledge into an area of specialty nursing to develop a level of clinical competence considered to be consistent with proficient specialty practice.
