Assessment:	A thesis of 12 000 words, due at the end of the second semester of enrolment. Supervision: Regular supervisory meetings</li> <li>2. Topic Proposal Form: To be submitted by the first week of the Semester of thesis enrolment</li> <li>3. Progress Report: To be submitted half way through the thesis year</li> <li>4. Thesis Draft: A full draft of the thesis is to be submitted approximately 5 weeks prior to the final thesis submission date. Final Theses submitted late without an approved extension will be penalised at 10% per working day.</li> </ol>
