<b>Subject Overview:</b>	This subject provides students with a critical understanding of international political economy, exploring links between international politics and economics in historical and contemporary perspective. An advanced introduction to a range of competing theoretical and methodological approaches to the study of international political economy is provided. Dilemmas of global economic governance are explored in relation to debates surrounding the role of major inter-governmental institutions such as the World Trade Organisation, the World Bank, the International Monetary Fund and the G20, and via examination of overlapping regimes of public and private power through which global systems of production, consumption, trade and finance are organised and governed. Key contemporary debates are explored, including divisions between developed and developing countries, the management of financial crises and the environmental consequences of a growth-based world economy.
<b>Learning Outcomes:</b>	On completion of this subject students should: <ul style="list-style-type: none"> <li># Develop a political and historical understanding of the major actors and events that have shaped the emergence of the contemporary international political economy;</li> <li># Develop comprehensive knowledge of the institutional regimes through which the international political economy is organised and governed;</li> <li># Strengthen skills in critically analysing competing empirical and theoretical claims regarding the consequences of contemporary globalisation;</li> <li># Develop skills in analysing and evaluating the design and operation of both public and private regimes of global economic governance.</li> </ul>
<b>Assessment:</b>	1. Written assessment of 500 (10%) due mid semester; 2. Written assessment of 2,000 words (40%) due towards the end of semester; 3. 3-hour exam, equivalent to 2500 words (50%) scheduled during the examination period. Hurdle Requirement: Students are required to attend a minimum of 75% of classes in order to qualify to have their written work assessed. Regular participation in class is required. Assessment submitted late without an approved extension will be penalised at 10% per working day. In-class tasks missed without approval will not be marked. All pieces of written work must be submitted to pass this subject.
