Subject Overview:	This subject addresses ethical issues and legal constraints involved in publishing for print and digital media. It will review existing ethical codes and the mechanisms established to police them, as well as offering an overview of how publishing practices are shaped by legislative provisions relating to such matters as intellectual property, privacy, defamation and respect for cultural differences. On successfully completing this subject, students will have gained an understanding of a wide range of ethical and legal considerations.
Learning Outcomes:	<ul> <li>be familiar with standard publishing industry practices and codes of conduct as they pertain to print and digital publishing;</li> <li>develop a strong understanding of the respective roles of editors, publishers and legal professionals in dealing with ethical and legal issues;</li> <li>understand the impact on publishing practice of laws pertaining to such matters as intellectual property, privacy, defamation and respecting cultural differences;</li> <li>be familiar with the issues involved in recent high-profile cases where standards have been breached; and</li> <li>demonstrate an ability to apply ethical and legal knowledge to their own editorial and publishing practice.</li> </ul>
Assessment:	2000 word defamation and contempt assignment 40% (due mid-semester), and final 3000 word essay 60% (due in the examination period). Students are required to attend a minimum of 80% (or 10 out of 12) classes in order to qualify to have their written work assessed. Any student who fails to meet this hurdle without valid reason will not be eligible to pass the subject. All required written work must be submitted in order to pass the subject. Essays submitted after the due date without an extension will be penalised 2% per day. Essays submitted after two weeks of
