<b>Subject Overview:</b>	Genocide, State Crime and the Law examines the differing roles played by law and legal process in the wake of genocide and other forms of state crime. It examines the limitations and potentials of law in addressing mass harm, in particular analysing the role and function of law in societal reconstruction and reconciliation. Case studies analysed include Rwanda, South Africa, East Timor, the former Yugoslavia, the Holocaust, Australia and Cambodia.
<b>Learning Outcomes:</b>	On completion of this subject students should: <ul style="list-style-type: none"> <li># Be familiar with a range of approaches to addressing genocide and state crime;</li> <li># Understand the social, political, cultural and historical contexts of legal and quasi-legal responses to genocide and state crime;</li> <li># Possess a critical understanding of these choices;</li> <li># Be able to critically and constructively discuss the limitations and potentials of law in the context of addressing mass harm;</li> <li># Be able to critically and constructively discuss the limitations and potentials of law in reconstruction and reconciliation.</li> </ul>
<b>Assessment:</b>	A 1,500 word paper (30%) due mid-semester and a 3,500 word research essay (70%) due during the examination period. Hurdle Requirement: Students are required to attend a minimum of 75% of classes in order to qualify to have their written work assessed. Regular participation in class is required. Assessment submitted late without an approved extension will be penalised at 10% per working day. In-class tasks missed without approval will not be marked. All pieces of written work must be submitted to pass this subject.
