Subject Overview:	This unit covers selected issues in contemporary metaphysics. We will focus on a particular philosophical issue (e.g. ontology, possibility, necessity, the nature of objects), and look at contemporary work addressing this issue.
Learning Outcomes:	<p>Students who successfully complete this subject will:</p> <ul style="list-style-type: none"> # show an understanding of selected issues in contemporary metaphysics; # manifest philosophical skill in arguing in an alert and well informed way for conclusions related to these issues; # display acquaintance with some important past contributions to the discussion of those issues; # indicate an awareness of how the subject matter is related to broader concerns in contemporary philosophy; # acquire the ability to locate issues concerning metaphysics; # learn to evaluate sophisticated arguments offered in the literature.
Assessment:	<p>A 500 word essay, due week 4 (10%) A 500 word essay, due week 8 (10%) A 4000 word essay, due in week 12 (80%) Hurdle requirement: Students must attend a minimum of 75% of classes in order to pass this subject. All pieces of written work must be submitted to pass this subject. Note: Assessment submitted late without an approved extension will be penalised at 10% per day. After five days late assessment will not be marked. In-class tasks missed without approval will not be marked.</p>
