<b>Subject Overview:</b>	Given social work's commitment to social justice and human rights, the ultimate purpose of understanding the policy environment is for social workers to become policy practitioners: monitoring policy from below, aware of differential impacts and committed to acting where there are adverse consequences for particular individuals, groups and communities. This may include advocacy on behalf of the most disadvantaged as well as developing strategies and processes that will empower those marginalised and excluded.  This subject will develop analytic and practical skills essential for social workers to become policy practitioners active in progressive reform through research, case advocacy, lobbying, social advocacy and promotion of grass roots activism.
<b>Objectives:</b>	This subject aims to assist students to theorise the broader domain in which they live and work as citizens and social work practitioners. It seeks to enhance their capacity to conceptualise abstract processes, describe the diversity and complexity of impacts as well as envisage and mobilize appropriate responses. It is based on the dictum that nothing is more practical than a good theory and that a good theory should be kept as simple as possible, but no simpler. It is an intellectually demanding, empirically rigorous and emotionally challenging area of study that will require the ability to transcend the limitations of ethnocentrism, to think beyond conventional paradigms and to consider initiatives and strategies for empowering those who are marginalized and excluded. At the end of the course students will be able to understand:
