<b>Subject Overview:</b>	Students undertake a research project and prepare a thesis. The thesis topic must be approved by the Graduate Studies Committee and any variation to the topic must be approved by the Committee. The thesis may be presented as: A study of approximately 30,000 words (excluding footnotes and appendices) embodying the results of significant research. OR A transcription and edition of a substantial body of music together with a critical study of between 10,000-20,000 words on the music edited.
<b>Objectives:</b>	To undertake a research project and prepare a thesis. The thesis topic must be approved by the Graduate Studies Committee and any variation to the topic must be approved by the Committee.
