<b>Subject Overview:</b>	<p>This subject is taken by students enrolled in the Graduate Diploma in Forensic Odontology. The formal teaching for this subject is given in one intensive, teaching period of 4 to 5 weeks. This compression of teaching is intended to assist and encourage interstate and overseas participants. The subject covers the law and law enforcement and more applied aspects of dental science, such as disaster victim investigation (DVI) procedures.</p> <p>The subject's two major components are:</p> <p><b>a. Applied Dental Science</b></p> <ol style="list-style-type: none"> <li>1. Dental materials</li> <li>2. Prosthetics - impression techniques - study model construction and duplication - denture marking.</li> <li>3. Preparation of Exhibits</li> <li>4. Anatomical reconstruction of facial features.</li> <li>5. Radiography and radiology.</li> <li>6. Fractures of bones and teeth.</li> <li>7. Soft tissue injuries.</li> </ol> <p><b>b. The Law and Law Enforcement</b></p> <ol style="list-style-type: none"> <li>1. The law and its constitutional basis.</li> <li>2. Dental ethics and jurisprudence.</li> <li>3. The organisation of police forces.</li> <li>4. Forensic Odontologist. Liaison with police and legal profession.</li> <li>5. The scene of crime</li> <li>6. Case preparation and presentation: <ol style="list-style-type: none"> <li>a) Coroners court</li> <li>b) Crown court. Defence and prosecution.</li> </ol> </li> <li>7. History of the Coronial system and duties of the Coroner.</li> <li>8. The functions of the Expert Witness.</li> <li>9. Legal implications of mass disasters and repatriation.</li> </ol>

<b>Assessment:</b>	Students are required to:(i) Sit two written examinations each of one and a half hours duration at the end of each semester. Each paper to be devoted to one of the subject's units (applied dental science and law and law enforcement).(ii) Take one oral examination of 45 minutes duration upon completion of the semester's taught content.(iii) Submit either: a type-written report of their research project, and/or, a type-written casework portfolio (suitable for binding) not less than 3 weeks before the end of the semester.(iv) Submit two essays of not more than 3,000 words each, for each of the subject's units. The topic will be set at the beginning of the semester.
