Subject Overview:	The capacity to generate ideas is both a fundamental characteristic of human beings and the source of humankind's cultural and economic advancement. This subject is concerned with the law's response to the issues of when and by whom ideas can be owned. In particular, it explores the rationale for and operation of copyright, patent, trade mark and other legal systems that regulate ownership of, and access, to the products of human creativity and innovation – in the creative arts, the sciences and the business world. Particular topics may include: <ul style="list-style-type: none"> # What types of ideas are capable of protection? # What rights are provided to the creators of ideas? # When can others make use of protected ideas?
Objectives:	On completion of this subject students should: <ul style="list-style-type: none"> # Appreciate the cultural and economic objectives and challenges in protecting the products of human creativity and innovation; # Recognise the types of creations and innovations protected by the law; and # Understand the basic features of the protection provided by the law to those creations and innovations.
Assessment:	Written assignments and/or in-class exercises totalling up to 2,000 words due by end of week 7 (35%); A 2-hour written examination in the examination period (65%). Satisfactory completion of both the assignment/exercise work and the examination is necessary to pass the subject.
Prescribed Texts:	A subject reader will be available.
