Course Overview:	Optometry is a professional discipline based on the optical and visual sciences. The practice of optometry involves the diagnosis and management of functional disorders and diseases of the eye and vision. An optometrist's job is to solve their patients' visual problems.
	The Doctor of Optometry is a 4-year full-time program that offers intensive training in the clinical discipline of optometry. The course covers the basic and applied vision sciences that underpin optometry, and delivers a comprehensive clinical training that commences in the first year of the study. During the course, students will have the opportunity to undertake a research project, in an area relevant to the discipline, and will be given the opportunity to undertake clinical training at an overseas site as part of their final year of study.
	Completion of the Doctor of Optometry satisfies the legislative requirements that permit students to register as optometrists in all states and territories of Australia and in New Zealand. The qualification also affords the opportunity, either with or without further study and examination, to register to practice in other countries around the world.

	<ul> <li>On successful completion of the course graduates should:</li> <li>have an understanding of the normal human visual system and its physical, chemical and biological foundations that enables them to apply their knowledge to practical situations in an effective and innovative way;</li> <li>be able to quantitatively describe light and its passage through optical systems (including ophthalmic instruments, ophthalmic lenses and the eye), design optical systems to meet required specifications, and quantitatively assess the nature and quality of optical images;</li> <li>have developed an advanced understanding of the mechanisms and associated manifestations of ocular and visual system disease at a level that allows them to construct appropriate differential diagnoses, and arrive at correct definitive diagnoses;</li> <li>have attained expert competency in clinical ocular examination using current best-practice methods, enabling them to fully assess and manage the health and visual performance of their patient;</li> <li>have an expert knowledge of best practice management strategies to enable the safe and effective use of ocular therapeutic drugs;</li> <li>have interpersonal and communication skills, both written and verbal, that allow them to establish and maintain professional relationships with their patients, professional colleagues and the general community;</li> <li>have the skills and knowledge to be competent in the practice of optometry at a level that enables them to achieve and sustain registration with the appropriate professional bodies;</li> <li>have the skills and knowledge required to manage the establishment, planning, promotion, finances, operations and workforce of an optometric practice.</li> </ul>

- have a strongly developed sense of professional and ethical responsibility for patients, colleagues and the community generally, and be aware of the moral and legal responsibilities of professional practice;
- have attained advanced skills in problem identification, and developed expertise in applying these skills to scientific problems in the visual and clinical sciences, as well as to particular problems presented by patients; and
- be prepared to take a leadership role in the advancement of optometry on a global stage, both in clinical and research spheres.
- have a sense of intellectual curiosity and a desire for lifelong learning, with the ability to adapt to scientific, technological and social change, and a capacity to be creative and innovative.

# Course Structure & Available Subjects:

Students must complete 400 credit points over the 4-year program. These 400 points of credit are accumulated from a compulsory series of six core subjects totalling 100 points per year.

#### **Entry Requirements:**

- 1. The Selection Committee will evaluate the applicant's ability to pursue successfully the course using the following criteria:
- An undergraduate degree (or equivalent); and
- a first, second or third year (or equivalent) subject in physics or optics; and a second or third year subject (or equivalent) in anatomy or cell biology; plus two additional subjects at second or third year level (or equivalent) from one or more relevant biological science disciplines.
- completion of either the GAMSAT (Graduate Australian Medical School Admissions Test), OAT (Optometry Admission Test (USA)), or the MCAT (Medical College Admission Test (USA)).
- a written statement submitted in accordance with the requirements of the Selection Committee.
- 2. The Selection Committee may conduct interviews or may call for referee reports to elucidate any of the matters referred to above.

Applicants who need to satisfy the University's English language requirements via an IELTS or TOEFL, will require one of the following:

- IELTS (Academic English only) 7.0 (written 7.0 with no band less than 6.0)
- TOEFL (paper-based test) 600 + TWE 5.0
- TOEFL (computer-based test) 250 + 5.0 essay rating

TOEFL (internet-based test) 100 + written score of 24 and no band less than 21

Guaranteed entry requirements:

For a guaranteed Commonwealth supported place (CSP) in the Doctor of Optometry degree\*:

- Achieve an ENTER (or equivalent) of 99.9 in studies undertaken in Australia until 2012;
- Commence an undergraduate course at the University of Melbourne and complete the undergraduate course with a H2A (75%) weighted average;
- Subject to satisfactory performance at an interview to demonstrate adequate communication skills. Successful applicants will not be required to complete the Graduate Australian Medical School Admission Test (GAMSAT) for entry. Prerequisite subjects must be completed.
- Note that guaranteed CSP places will be limited by the number of CSP places available in the course in the year of entry.\*

For a guaranteed fee place (Australian or international) in the OD graduate degree\*:

- Achieve an ENTER (or equivalent) of 99.0 in studies undertaken in Australia until 2012;
- Commence an undergraduate course at the University of Melbourne and complete the undergraduate course with a H2A (75%) weighted average;
- Subject to satisfactory performance at an interview to demonstrate adequate communication skills. Successful applicants will not be required to complete the Graduate Australian Medical School Admission Test (GAMSAT) for entry. Prerequisite subjects must be completed.
- Note that guaranteed fee places will be limited by the number of fee places available in the course in the year of entry.\*
- \*The maximum number of places (CSP & Fee) offered in any one year will be limited by available clinical training capacity.

	academic study, and reasonable adjustments will be made to enhance a student's participation in the degree. The Doctor of Optometry requires all students to enrol in subjects where they will require: (1) the ability to comprehend complex science and technology related information; (2) the ability to clearly and independently communicate a knowledge and application of science, and technology principles and practices during assessment tasks; (3) the ability to actively and safely contribute in clinical, laboratory, and fieldwork/excursion activities. Students must possess behavioural and social attributes that enable them to participate in a complex learning environment. Students are required to take responsibility for their own participation and learning. They also contribute to the learning of other students in collaborative learning environments, demonstrating interpersonal skills and an understanding of the needs of other students. Assessment may include the outcomes of tasks completed in collaboration with other students. There may be additional inherent academic requirements for some subjects, and these requirements are listed within the description of the requirements for each of these subjects. Notes:	Please note that the purchase of some equipment may be necessary for various compulsory subjects within this course. The Department of Optometry and Vision Sciences will facilitate this process during the first year of the course. Students should have an approved direct ophthalmoscope and retinoscope, gonioprism, binocular indirect ophthalmoscope, two fundus lenses, white coat, pre-focused pen torch or transilluminator, inter-pupillary rule, cover paddle, and a set of four flippers (lenses and prisms). Students are strongly advised to purchase

their own equipment, which they will continue to use during their course and after graduation. However, those students who do not have their own equipment will be able to borrow equipment for classes.
