<b>Objectives:</b>	On completion of the project students will have: <ul style="list-style-type: none"> <li>• Gained an understanding of the procedures and methods including involved in conducting organised research including the identification of hypotheses and thus be capable of acquiring and developing knowledge in computer forensics and e-crime investigations through rigorous and independent research.</li> <li>• Developed and demonstrated an appreciation of research design and planning and understand how the creation, dissemination and application of knowledge are intimately related.</li> <li>• Developed skills in managing information particularly in regard literature surveys, effective use of libraries and the use of multimedia for research</li> <li>• Gained skills in the communication and presentation of research findings and be capable of independent critical thought.</li> </ul>
