<b>Subject Overview:</b>	This subject focuses on the role of the professional financial adviser in personal financial planning. Topics will be drawn from: risk and return analysis; investment asset classes; features of different investment products; taxation issues relating to securities and the impact of tax on various investment choices; the advantages and disadvantages of gearing; estate planning; rent versus buy decision-making problems; superannuation issues; insurance; relevant legal principles and industry standards; codes of conduct and the relationship between ethics and regulatory requirements.
<b>Objectives:</b>	On successful completion of this subject students should be able to: <ul style="list-style-type: none"> <li># Explain the features of various retail investment asset classes;</li> <li># Analyse risk and effective return;</li> <li># Critically evaluate the features of different investment products and their suitability for clients;</li> <li># Explain the relationship between ethics and regulatory requirements and be aware of relevant legal principles, industry standards and codes of conduct;</li> <li># Analyse the after-tax impact of various investment choices;</li> <li># Explain and demonstrate the advantages and disadvantages of gearing;</li> <li># Analyse and evaluate renting versus buying decision-making problems;</li> <li># Identify and calculate eligibility for social security benefits;</li> </ul>

	<ul style="list-style-type: none"> <li># Synthesise, and apply to individual circumstances, the fundamental issues surrounding superannuation;</li> <li># Critically evaluate the importance of estate planning in the financial planning process;</li> <li># Identify and explain the principles concerned with different types of insurance.</li> </ul>
