<b>Subject Overview:</b>	This subject applies modern financial techniques to the management of diversifiable risks. These techniques include hedging, real options, portfolio design, swaps and leverage; and are combined with concepts such as corporate behavioural finance and utility functions. This enables students to develop quantitative measures of diversifiable, or business, risks and manage them effectively. The aim is to provide a comprehensive theoretical understanding of the nature and sources of diversifiable risks - financial risk strategy - so that these risks can be leveraged strategically.						
<b>Objectives:</b>	On successful completion of this subject, students should be able to: <ul style="list-style-type: none"> <li># Explain factors that predispose organisations to operational and financial risks and hazards;</li> <li># Recognise and identify business risks;</li> <li># Apply modern techniques to the management of business risks;</li> <li># Successfully develop and apply risk management tools and solutions;</li> <li># Explain linkages between organisation risk propensity and financial outcomes.</li> </ul>
