<b>Subject Overview:</b>	The central aim of this subject is to consider how, why, and in whose interests the law intervenes in family relationships on relationship breakdown. The subject aims to develop students' understanding not only of 'black letter' law (case law and statute), but also of family law in its broader social context, including an understanding of the processes of social policy reform.  The subject is divided into three topic areas: <ul style="list-style-type: none"> <li># Overview of the family law system;</li> <li># Children and parents;</li> <li># Financial aspects of relationship breakdown.</li> </ul>
<b>Objectives:</b>	On successful completion of this subject, students should be able to:  <ul style="list-style-type: none"> <li># Demonstrate an understanding of the legal frameworks that regulate the rights and responsibilities of family members in Australia on relationship breakdown;</li> <li># Apply analytical, critical, theoretical and evaluative skills to legal and social policy issues associated with the family;</li> <li># Apply the relevant case law and legislation to hypothetical problems;</li> <li># Demonstrate an understanding of the application of family law in practice;</li> <li># Demonstrate an awareness of the factors relevant to the processes of law reform as it applies to the family.</li> </ul>
<b>Assessment:</b>	Final written examination three hours (worth 100% of the final mark in the subject). The written examination will be open-book. Duration 30 minutes reading time and 3 hours writing time.
<b>Prescribed Texts:</b>	Printed materials will be available from Melbourne Law School.
