The subject is thus particularly valuable for students wishing to prosecute trade mark applications through the Australian Trade Marks Office. The rights, privileges and responsibilities of a patent or trade mark attorney are also covered. The lecturers are experienced trade mark law lecturers and practitioners. The emphasis of this subject is on the documentation and procedures involved and the relevant practice of the Australian Trade Marks Office.
