Most subjects assume the knowledge usually acquired in a degree in law (LLB, JD or equivalent). Applicants should note that admission to some subjects in the Melbourne Law Masters will be dependent upon the individual applicant's educational background and professional experience.

<b>Core Participation Requirements:</b>	The Melbourne Law Masters welcomes applications from students with disabilities. <b>Subject Overview:</b>	<p>This subject builds upon the material covered in the Trade Marks and Unfair Competition subject. Trade Mark Practice is primarily concerned with the procedures and practices of the Australian Trade Marks Office in obtaining and maintaining a registered trade mark.</p> <p>The subject is thus particularly valuable for students wishing to prosecute trade mark applications through the Australian Trade Marks Office. The rights, privileges and responsibilities of a patent or trade mark attorney are also covered. The lecturers are experienced trade mark law lecturers and practitioners.</p> <p>The emphasis of this subject is on the documentation and procedures involved and the relevant practice of the Australian Trade Marks Office.</p> <p>Principal topics will include:</p> <ul style="list-style-type: none"><li># The Trade Marks Office, the Trade Marks Register and the Official Journal of Trade Marks</li></ul>

	<ul style="list-style-type: none"> <li># Determining the availability of a trade mark for use and registration, searching the Trade Marks Office database and other search options</li> <li># Applications for registration, including Madrid Protocol, Convention, divisional and series applications</li> <li># Examination and acceptance of applications</li> <li># Opposition to registration</li> <li># Amendment of applications and other documents</li> <li># Obtaining registration and renewal of registration</li> <li># Obtaining extensions of time</li> <li># Special procedures relating to collective, certification and defensive trade mark applications</li> <li># International conventions and initiatives, and protecting trade marks in foreign countries</li> <li># The rights, privileges and responsibilities of a patent or trade mark attorney.</li> </ul>
