<b>Subject Overview:</b>	This subject examines the modern public sector management function through a range of practical and theoretical perspectives. Focusing on placing public sector management into surrounding historical and quasi-ideological debates, the subject explores the nature of public sector management, its capabilities and boundaries, technologies of management and their associated functional applications, and the limitations of existing paradigms, policy tractability, and political will to deliver "public value" (if there can be such a thing). Focused on critical case analysis, the subject requires a good understanding of political and public policy processes and contexts at the local, state, federal levels of Australia, and a willingness to participate in group discussion, activities and study. Participants will leave the subject with a broad introduction to public sector management as well as skills and techniques for investigating management issues.
<b>Objectives:</b>	<ul style="list-style-type: none"> <li># have an understanding of the ways in which government programs are managed at Commonwealth, state and local levels in Australia.</li> <li># develop skills in researching and analysing management issues.</li> </ul>
<b>Assessment:</b>	An essay proposal of 1500 words (25%) due early in the semester, and an essay of 3500 words (75%) due at the end of semester. Hurdle Requirement: Students are required to attend a minimum of 75% of classes in order to qualify to have their written work assessed. Students who fail to meet this hurdle requirement will be deemed ineligible to submit the final piece of assessment for this subject. Regular participation in class is required. Assessment that is submitted after the due date and up to 10 working days late without an approved extension will be marked on a pass/fail basis only. Assessment that is submitted later than 10 working days will not be accepted or marked. In-class tasks missed without approval will not be marked. All pieces of written work must be submitted to pass this subject.
