<b>Subject Overview:</b>	This subject examines the dynamics of contemporary public governance in Australia and overseas. Students will investigate traditional and emerging governance models, with an emphasis on the changing nature of governance in the "network society", against the backdrop of an increasingly global social and economic order. Attention will be given to contemporary changes to the organisation of the public sector in both industrialised and non-OECD countries, and to the increasing role of civil society and other non-governmental actors in contemporary governance processes. The subject will combine theoretical work on the nature of contemporary governance with studies of current policy and program debates. On completion of this subject students should have a well developed critical understanding of a range of governance models operating in contemporary society; understand the implications of emergent governance models for civil society and other non-government actors; understand the relationship(s) between global influences and emerging governance frameworks; have developed the analytical skills necessary to apply the above knowledge to critical evaluation of policy development and implementation in Australian and international contexts.

<b>Assessment:</b>	A 2500-word essay (50%) due early April, and a 2500-word essay (50%) due during the examination period. Hurdle Requirement: Students are required to attend a minimum of 75% of classes in order to qualify to have their written work assessed. Students who fail to meet this hurdle requirement will be deemed ineligible to submit the final piece of assessment for this

	subject.Regular participation in class is required. Assessment that is submitted after the due date and up to 10 working days late without an approved extension will be marked on a pass/fail basis only. Assessment that is submitted later than 10 working days will not be accepted or marked. In-class tasks missed without approval will not be marked. All pieces of written work must be submitted to pass this subject.
