| <b>Subject Overview:</b>                 | The focus of this subject is on the clinical and social aspects of serious mental illness. Developments in the treatment of mental illness have led in recent years to the de-institutionalisation of mental health services. This has resulted in a focus on community mental health and changing roles for members of the mental health team. Consideration will be given to exploring and understanding the importance of the experience of treatment and the effect of serious mental illness. This will include discussion of biological psychiatry's contribution to treatment, the exploration of community perspectives and the importance of psychosocial rehabilitation. |
