Subject Overview:	This subject examines the historiographical foundations, theoretical frameworks, and recent developments, of the discipline art history from the Renaissance to the present. It critically examines a range of methodological approaches to the interpretation of particular works of art, with an eye to their application in the student's own research projects.
Objectives:	<ul> <li>Students who complete this subject will:</li> <li># have an understanding of the historiography of art history from the Renaissance onwards;</li> <li># be able to critically engage with and apply competing methodological approaches in art history; and</li> <li># have an advanced understanding of the theoretical foundations of particular instances of art historical practice.</li> </ul>
Assessment:	A 1000 word class paper 20% (due during the semester), and a 4000 word essay 80% (due in the examination period). Students are required to attend a minimum of 80% (or 10 out of 12) classes in order to qualify to have their written work assessed. Any student who fails to meet this hurdle without valid reason will not be eligible to pass the subject. All required written work must be submitted in order to pass the subject. Essays submitted after the due date without an extension will be penalised 2% per day. Essays submitted after two weeks of the assessment due date without a formally approved application for special consideration or an extension will only be marked on a pass/fail basis if accepted.
