Subject Overview:	Following indications from thinkers such as Muecke, Elkin, Bird Rose, Swain, Mowaljarlai and others, this subject will ask the following questions: # Is there an Aboriginal philosophy? # What fundamental principles might such a philosophy be grounded in? # Would it be an Australian philosophy? An analysis of tropes and images and identification of structural commonalities in some of the Australian Indigenous works we will be studying will provide a framework for this discussion.
Objectives:	Students who successful complete this subject will: # experience an expansion in intellectual horizons and the ability to participate in original work in the field of Australian Indigenous studies; # learn to make distinctions between essential and transitory aspects of Aboriginal culture and philosophy; and # understand the implications of an Aboriginal philosophy in any consideration of social and ecological issues affecting contemporary Australian society and the reconsideration of the idea of an Australian nation in the 21st century.
Assessment:	5000 word essay 100% (due in the examination period). Students are required to attend a minimum of 80% (or 10 out of 12) classes in order to qualify to have their written work assessed. Any student who fails to meet this hurdle without valid reason will not be eligible

	to pass the subject. All required written work must be submitted in order to pass the subject. Essays submitted after the due date without an extension will be penalised 2% per day. Essays submitted after two weeks of the assessment due date without a formally approved application for special consideration or an extension will only be marked on a pass/fail basis if accepted.
