<b>Assessment:</b>	Assessment will include a combination of one open book test and three assignments. <ul style="list-style-type: none"> <li>• One open book test representing 20% of the total mark, completed at the end of the first week of lectures.</li> <li>• Two 1000 word assignment each representing 25% of the total mark (a combined total of 50%)</li> <li>• One 1500 word workplace assignment representing 30% of the total mark. Each written essay is submitted progressively through the semester. A minimum score of 50% in each assessment is required for a student to pass this subject.</li> </ul>
