<b>Subject Overview:</b>	The focus of this subject is on relating children's language acquisition and theories of learning to literacy development in the Reading Recovery program. This subject provides a vehicle for students to re-examine and refine their teaching assumptions, expectations and practices, within the broad context of literacy teaching and learning, and identify the links between classroom practices and the Reading Recovery program.
<b>Objectives:</b>	On completion of this program, students should be able to: <ul style="list-style-type: none"> <li># Understand the relationship of Reading Recovery practice to research on the principles of language and literacy acquisition;</li> <li># Be able to articulate the broad educational principles underlying Reading Recovery pedagogy;</li> <li># Be able to identify the links between regular classroom practice and the Reading Recovery program.</li> </ul>
<b>Assessment:</b>	20-minute class presentation (40%); a 3000 word written assignment (60%) due two weeks after the intensive delivery period.
