Subject Overview:	This is a capstone subject for the program consisting of selected case studies from topics including: financial management, investment management, portfolio analysis, derivatives and risk management, mergers and acquisitions, raising capital and other topical issues. The case studies describe actual business situations faced by financial managers, which requires analysis and decision-making.
Objectives:	On successful completion of this subject students should be able to: <ul style="list-style-type: none"> # Interpret basic financial statements and explain how they link together; # Explain and apply ratio analysis in valuation; # Explain how fundamental values (or 'intrinsic values') are estimated; # Apply, evaluate and compare current technologies to value firms using financial information; # Explain business activities that determine value, and identify 'value created for shareholders'; # Explain the funding alternatives available to firms; # Evaluate the consequences of mergers and acquisitions; # Describe the nature and role of derivatives in risk management.
Assessment:	One 3-hour examination (70%) Assignments totalling not more than 3000 words (30%)
