<b>Subject Overview:</b>	The investment management process, review of fundamental concepts, market efficiency, capital market characteristics and risk premia, setting investment objectives, strategic and tactical asset allocation, active/passive management, property, bond and equity portfolio management, investment performance measurement, asset allocation modelling and its application to portfolio management.						
<b>Objectives:</b>	<p>On successful completion of this subject students should be able to:</p> <ul style="list-style-type: none"> <li># Explain the institutional investment process, including setting investment objectives, and its impact on the fund managers role;</li> <li># Consider the limitations of financial data available to a fund manager;</li> <li># Interpret the usefulness of financial data when making investment decisions;</li> <li># Compare and contrast an active versus passive approach to fund management;</li> <li># Discuss strategic versus technical asset allocation decisions, including the impact of capital market characteristics in the long and the short run on these decisions;</li> <li># Critically evaluate behavioural finance implications in fund management decisions;</li> <li># Apply performance measurement methods to managed portfolios.</li> </ul>
