<b>Subject Overview:</b>	Meat production alternatives in Australia; microscopic and macroscopic structure of meat muscle; components of meat, interrelationships and surface chemistry; meat processing: role of non-meat functional ingredients, inhibition of microbial growth, fermentation of meat, prefabricated meat processing, packaging and storage conditions; factors influencing quality of product from farm to plate; identification of waste management issues; regulatory framework; current and future developments in products and processes.
<b>Objectives:</b>	<p>The objective of this subject is to introduce students to the science and technology associated with the transformation of muscle and other carcass tissues to fresh and processed meat products.</p> <p>On completion of this subject, students should have an understanding of:</p> <ul style="list-style-type: none"> <li># Factors affecting the growth and development of meat animals</li> <li># The structure, function and growth of muscle tissue</li> <li># The biochemical composition of muscle and post-mortem changes</li> <li># Microorganisms and meat spoilage</li> <li># The storage and preservation of meat and meat products</li> <li># Cured, fermented and prefabricated meat products</li> <li># Factors influencing meat quality from 'paddock to plate'</li> </ul>
<b>Assessment:</b>	Two assignments of 1,000 words each on: 1. Pre-slaughter factors affecting quality or similar topic (20%), due mid-way through semester, 2. An aspect of meat and smallgoods processing, or similar topic (20%), due one week prior to the end of semester. Reports (20%) based on practical activities and/or field visits to meat processing plants, due one week after the practical activity/visit. Two hour written examination (40%).
