<b>Course Structure &amp; Available Subjects:</b>	To satisfy the requirements of the Specialist Certificate in Clinical Research (Clinical Trial Coordination), students must successfully complete the two compulsory subjects, including a work-based assessment (a total of 25 points) to be awarded the degree.
