<b>Subject Overview:</b>	This subject provides a comprehensive introduction to micro-economics. It is suitable for students with no prior knowledge of economics. It paves the way for students to apply micro-economic concepts to the analysis of contemporary issues in public health and health care. Topics to be studied include the following: <ul style="list-style-type: none"> <li>• Introduction to economics and micro-economics,</li> <li>• Introduction to health economics,</li> <li>• The demand for health and health care,</li> <li>• The supply of health manpower and services: doctors and hospitals,</li> <li>• The market of health care,</li> <li>• Market failure and the role of government in health care,</li> <li>• The Australian health care system analysed from an economic perspective,</li> <li>• Australia's Medicare system analysed from an economic perspective.</li> </ul>
