Overview:	The Master of Public Policy and Management is the premier public policy program in Australia. For more than 30 years it has prepared students for leadership roles in Australia and internationally. It is designed for current public, private and community sector leaders and managers, as well as those wishing to begin a career in public policy and management. The program draws upon the expertise of academics engaged in researching public policy and of senior leaders from state and federal government and public service delivery organisations.

Capstone Stream 4: Minor Thesis - Public /Social Policy (PPMN90002)

Purpose: An opportunity to integrate knowledge and research skills to address a research question; Pathway to the PhD
