<b>Subject Overview:</b>	This course focuses on fundamental approaches to research and the range of analytical and empirical research methods and techniques used in accounting. On completion of this subject a student should have a foundation for understanding the nature of scientific inquiry in accounting; an understanding of how research questions are created and developed into testable hypotheses; an appreciation of the range of alternative methods used and an ability to critically analyse the research of others in the field of accounting.
<b>Learning Outcomes:</b>	On successful completion of this subject, students should be able to: <ul style="list-style-type: none"> <li># Identify and evaluate the fundamental approaches to research;</li> <li># Classify and describe a range of analytical and empirical techniques;</li> <li># Apply analytical and empirical techniques to research questions;</li> <li># Critically evaluate existing work;</li> <li># Discuss issues surrounding scientific enquiry in accounting research;</li> <li># Apply relevant research, analytical and empirical methods to philosophy of science, research design, experimental research, archival research, survey research, case research, data analysis and ethics in research.</li> </ul>
<b>Assessment:</b>	Weekly problem and exercise based assignments during the first half of semester covering half the course (50%) and a take-home end-of-semester examination not exceeding 4000 words covering half the course (50%).
