<b>Subject Overview:</b>	Topics include collective risk model, calculation of moments and mgf of aggregate claims, recursion formulae, effect of reinsurance; individual risk model, recursion formulae and approximations; credibility theory, exact credibility and the Buhlmann-Straub model; an introduction to ruin theory.						
<b>Learning Outcomes:</b>	<ul style="list-style-type: none"> <li># Apply relevant pre-requisite knowledge of mathematics, probability theory and statistics in the solution of a range of practical problems;</li> <li># Derive and calculate probabilities for, and moments of, loss distributions both with and without simple reinsurance arrangements;</li> <li># Construct risk models appropriate for short term insurance contracts and derive both moments and moment generating functions for aggregate claim amounts under these models;</li> <li># Derive recursion formulae to calculate aggregate claims distributions for short term insurance contracts;</li> <li># Describe and apply approximate methods of calculating an aggregate claims distribution;</li> <li># Explain the fundamental concepts of Bayesian statistics and apply these concepts to derive Bayesian estimators;</li> <li># Describe and apply the fundamental concepts of credibility theory;</li> <li># Explain the concept of ruin for a risk model;</li> <li># Explain the significance of the adjustment coefficient in ruin theory.</li> </ul>
