<b>Subject Overview:</b>	Students undertaking the criminology honours thesis should demonstrate a clear understanding of a specific field of study at an advanced level. They should demonstrate clear thinking and an ability to integrate theory and method in a logical manner. Students must be able to work in a concentrated way over an extended period of two semesters and must present their research in a scholarly fashion.						
<b>Learning Outcomes:</b>	On completion of this subject students should: <ul style="list-style-type: none"> <li># understand the process of research, including compliance with any ethical requirement of the university concerning research;</li> <li># develop a comprehensive understanding of the criminological literature relevant to their research;</li> <li># be able to integrate theory and method in a logical manner.</li> </ul>						
<b>Assessment:</b>	A thesis of 12 000 words (100%) due at the end of the second semester of enrolment. The following Hurdle Requirements must be met in order for students to be eligible to submit the final Thesis: 1. Supervision: Regular supervisory meetings 2. Topic Proposal Form: To be submitted by the first week of the Semester of thesis enrolment 3. Progress Report: To be submitted half way through the thesis year 4. Work-in-Progress Conference: Students are required to present a 10 minute paper on their findings-to-date 5. Thesis Draft: A full draft of the thesis to be submitted approximately 5 weeks prior to the final thesis submission date. Final Theses submitted late without an approved extension will be penalised at 10% per working day.
