<b>Subject Overview:</b>	This subject builds on the work covered in ECON90003 Macroeconomics. The focus is on providing a detailed coverage of particular topics of contemporary importance. Topics covered may include: <ul style="list-style-type: none"> <li># Macroeconomic dynamics;</li> <li># Macroeconomic models of the open economy;</li> <li># Economic growth;</li> <li># Credit rationing;</li> <li># The monetary transmission mechanism;</li> <li># Irreversibility and investment;</li> <li># Problems in desinging and implementing macroeconomic policies;</li> <li># Analyses of unemployment and the labour market; and</li> <li># Consumption theory.</li> </ul>						
<b>Learning Outcomes:</b>	On successful completion of this subject students should be able to: <ul style="list-style-type: none"> <li># Solve differential and difference equations and apply these solutions to explain possible macroeconomic outcomes;</li> <li># Apply basic dynamic techniques to macroeconomic models in order to solve for short-run and long-run outcomes;</li> <li># Apply the techniques of static and dynamic optimisation to solve macroeconomic problems;</li> </ul>						

	<ul style="list-style-type: none"> <li># Apply dynamic macroeconomic models to explain likely economic outcomes in the short-run, in the long-run and in the transition from short-run to long-run equilibria;</li> <li># Use optimisation techniques to derive theoretical models that can explain the behaviour of economic agents;</li> <li># Integrate theoretical models based on optimising behaviour into full-scale models of the macro-economy;</li> <li># Explain some techniques economists use to empirically evaluate macroeconomic models.</li> </ul>
<b>Assessment:</b>	One 3-hour end of semester examination (60%) Four class assignments totalling approximately 4000 words, due weeks 3, 6, 9 and 12 (40%)
