This placement must be undertaken in a different setting to Professional Practice SLD 1 and cannot be undertaken in your workplace. The diagnosis and intervention implemented targets multiple specific learning disability needs, for example, literacy, numeracy and social learning needs. Possible settings can be either segregated or inclusive. The setting provides students with the opportunity to design, implement and evaluate programs for students with special needs. Students will need to attend professional experience workshops/seminars.
