<b>Subject Overview:</b>	A series of weekly seminars dealing with the examination of texts and works of art formative in contemporary critical practices. The course is run as a reading group and critical workshop. Discussion is focussed on critical methods and arguments demonstrated in the reading material and, according to opportunity, on current art exhibitions or events.
<b>Learning Outcomes:</b>	This subject will enable students to: <ul style="list-style-type: none"> <li>• develop an understanding of the professional and institutional practices that comprise the contemporary art profession;</li> <li>• demonstrate through critical writing and discussion the capacity to articulate judgements and opinions that reflect an understanding of the field;</li> <li>• engage professionally within the institutional context of contemporary art.</li> </ul>
<b>Assessment:</b>	One written paper of 5,000 words, or equivalent (100%). Hurdle Requirement: 80% attendance at seminars is required for the written component to be accepted for assessment.
<b>Prescribed Texts:</b>	A class reader will be available for purchase.
<b>Recommended Texts:</b>	Further recommended reading as per the class reader.
