Subject Overview:	This subject examines the social, political and cultural history of the many central and northern Italian cities which participated in the culture of the Renaissance, with special case studies of Florence and Venice. Major themes explored are: politics and urbanisation; art, architecture and patronage; religion and popular beliefs; the family and gender roles; luxury and consumption; humanism and education. Throughout students will be encouraged to reflect on the meaning and usefulness of the term 'Renaissance' as an historical construct. Students should complete this subject with a well-rounded picture of the Renaissance as a social and cultural context, which has left a profound impact upon the culture of the west in the succeeding centuries, including our own.
Learning Outcomes:	Students who complete this subject will:  • gain a better understanding of the social, political and cultural aspects of the Renaissance;  • gain an understanding of the role of Florence and Venice in the culture of the Renaissance;  • be able to reflect critically on periodization in History, and on the term 'Renaissance' as an historical construct;  • be able to analyse primary and secondary sources in constructing historical arguments.
Assessment:	A reflective journal of 1500 words 40% (due mid semester) and a research essay of 2500 words 60% (due during the examination period). Hurdle requirement: students must attend a minimum of 75% of tutorials in order to pass this subject. Assessment submitted late without an approved extension will be penalised at 10% per day; after five working days, no late assessment will be marked. In-class tasks missed without approval will not be marked. All pieces of written work must be submitted to pass this subject.
