This qualification is recognised by the International Baccalaureate in relation to the IB Certificate in Teaching and Learning.</p> <p>This course is suitable for students requiring eligibility for the IB Advanced Certificate in Teaching and Learning.</p> <p>This is a fee paying course.</p>

Entry Requirements:	<p>1. In order to be considered for entry, applicants must have completed: either</p> <ul style="list-style-type: none"> # an undergraduate degree in a cognate discipline and an additional one year teaching qualification, or # a four-year teaching degree; or # an undergraduate degree in any discipline and documented relevant professional or teaching experience that demonstrate a capacity to succeed in a course for which an undergraduate degree and formal teaching qualifications are normally required. <p>Meeting these requirements does not guarantee selection.</p> <p>2. In ranking and/or assessing applications, the Selection Committee will consider:</p> <ul style="list-style-type: none"> # prior academic qualification and performance; and, if relevant # the professional experience. <p>3. The Selection Committee may seek further information to clarify any aspect of an application in accordance with the Admission and Selection into Course Policy.</p> <p>4. Applicants are required to satisfy the university's English language requirements for postgraduate courses. For those applicants seeking to meet these requirements by one of the standard tests approved by the Academic Board, performance band 6.5 is required.</p>		
Core Participation Requirements:	<p>The Melbourne Graduate School of Education welcomes applications from students with disabilities.
