<b>Subject Overview:</b>	This subject explores the practical 21st Century application of theories of communities of practice as described by Wenger and Lave, and others. It explores virtual learning communities with a particular focus on open source tools and resources. Underlying this investigation is a theoretical framework designed to make relevant and contextual links between theory and practice. The subject should be of interest to educators from all sectors including primary and secondary, tertiary, industry and training, and others interested in the use of modern applications to support learning communities. <b>Assessment:</b>	<p>1500 word essay: Negotiated essay on aspects of digital technologies in the support of learning communities, due mid semester, 30% Project equivalent to 2250 words: A practical application of the use of digital technologies in the support of learning communities, due mid semester, 45% Contribution: involvement in discussion of weekly readings, making regular contributions to the learning community website, throughout the semester, 10% 750 word essay: Constructive review of a student project, due end of semester, 15% Attendance at all classes (tutorial/ seminars/practical classes/lectures/labs) is obligatory. Failure to attend 80% of classes will normally result in failure in the subject.</p>
