<b>Subject Overview:</b>	This subject addresses the policy and governance framework for forest management in international, national and state contexts. It describes policy processes and the role of different actors in policy development and implementation. Different policy instruments are described and their suitability for achieving policy objectives is discussed. Current issues in international forest policy, such as illegal logging and trade, conservation, certification, environmental management, forests and poverty and climate change are considered from the viewpoints of different forest policy actors. This subject will equip students with an improved capacity for critical thinking in relation to policy issues.
<b>Learning Outcomes:</b>	At the completion of this subject students will have a sound understanding of: <ul style="list-style-type: none"> <li># international, national and state forest and environmental policies and legislation</li> <li># processes for policy development and negotiation</li> <li># the role of various policy actors and their different perspectives</li> <li># policy instruments and their suitability for achieving policy objectives</li> <li># current issues in international forest policy, including: deforestation, illegal logging and trade, forests and climate change, forests in poverty alleviation and international development, forest biodiversity conservation, forest certification systems and the role of international bodies and processes in forest policy</li> </ul>
