Subject Overview:	<p>Aims</p> <p>This subject familiarises students with core informatics tools and methods used in eHealth, translational research, simulation and modelling, and biomedical knowledge management. It also provides students with insights into research trends in the field of biomedical informatics.</p> <p>Indicative Content</p> <p>Five major topics will be covered in lectures, tutorials and hands-on computer labs:</p> <ol style="list-style-type: none"> 1. How can we manage clinical data? Students will gain exposure to: informatics tools and methods for ehealth and broadband-enabled health, including shareable medical records, telehealth, mobile health; terminologies, coding and standards e.g. SNOMED-CT, HL7A and secure messaging, medical imaging (DICOM) and lab data (LOINC); and clinical decision support systems. 2. How can we integrate clinical data with molecular, population, environmental and other data sources? Students will gain exposure to: informatics tools and methods for translational research, including genomic data sources (microarray and next generation DNA sequencing); data integration and analysis platforms such as BioGrid, CaBIG. Gene ontology; and clinical research informatics (clinical trials). 3. How can we use computer models to simulate human biology and disease? Students will gain exposure to: informatics tools and methods for simulation and modelling; anatomical 								

	<p>ontologies (FMA); VPH and Physiome platform; and infodemiology tools, systems medicine, virtual environments for clinical practice.</p> <p>4. How can we manage health and biomedical knowledge? Students will gain exposure to: informatics tools and methods for biomedical informatics research, including bibliographic and web information; MeSH, and databases; biomedical text mining; social and semantic web for health and life sciences; technology assessment; and systematic reviews and meta-analyses.</p> <p>5. How can we develop the next generation of health and bioinformatics tools and methods? Students will gain exposure to trends and advances, including extreme phenotyping, informatics for personalised, regenerative and nanomedicine.</p>
Learning Outcomes:	<p>Intended Learning Outcomes (ILOs)</p> <p>On completion of this subject the student is expected to:</p> <ol style="list-style-type: none"> 1 Describe key informatics tools and methods used in eHealth, translational research, simulation and modelling, health and biomedical knowledge management 2 Map typical needs in eHealth, translational research, simulation and modelling, health and biomedical knowledge management onto specific informatics tools and methods 3 Demonstrate an understanding of how clinical data is integrated with molecular, population, environmental and other data sources 4 Demonstrate an understanding of how computer models simulate human biology and disease, through a variety of informatics tools and methods for simulation and modelling 5 Work knowledgeably towards resolution of research challenges in the field of biomedical informatics.
Assessment:	<p>Five written reports based on individual computer-based learning tutorials / practical activities (10% each). Approximately 500 words each. Due weekly in week 1 through week 5 of 5. Each requires approximately 13-15 hours of work per student, including preparation. Intended Learning Outcomes (ILOs) 1, 2, 3 & 4 are addressed in these assignments. Project report on a comparative study of two or more specific EHBI tools, or two or more specific EHBI methods, exact focus as negotiated with teaching staff (50%). 10 minute class presentation due in week 5 of 5; written report of approximately 2000 words due two weeks after the last class. Requires approximately 70-75 hours of work per student. Group projects are optional; 1000 additional words and 5 additional minutes of class presentation are required for each extra person, i.e. 2 people = 3000 words +15 minute presentation; 3 people = 4000 words + 20 minute presentation, etc. Each group member commits approximately 70-75 hours of work and receives the same mark. ILOs 5 and also 1, 2, 3, or 4 (depending on topic) are addressed in this assignment.</p>
