<b>Recommended Background Knowledge:</b>	Applicants without legal qualifications should note that subjects are offered in the discipline of law at an advanced graduate level. Most subjects assume the knowledge usually acquired in a degree in law (LLB, JD or equivalent). Applicants should note that admission to some subjects in the Melbourne Law Masters will be dependent upon the individual applicant's educational background and professional experience.

<b>Subject Overview:</b>	<p>The world's first feature-length film was thought to have been produced in Australia in 1906. <i>The Story of the Kelly Gang</i> told the story of Australia's most infamous bushrangers and received distribution in Britain and New Zealand as well as in Australia. From 1906 onwards, Australian films and television programs such as <i>Picnic at Hanging Rock</i>, <i>The Castle</i>, <i>Shine</i> and <i>The Sullivans</i> have helped to define the particular cultural identity of Australians. This subject explores the issues associated with the production, financing and distribution of such films and television programs, with particular reference to feature films and sport and drama television programming. The lecturer in the subject has been an in-house counsel at an Australian television network and this experience adds to the practical relevance of the subject.</p> <p>Principal topics will include:</p> <ul style="list-style-type: none"> <li># Introduction to relevant legislation, regulatory and industry bodies and the structure of the Australian film and television industry</li> <li># Copyright clearance issues</li> <li># Moral rights</li> <li># Breach of confidence and privacy</li> </ul>

<b>Assessment:</b>	Class participation (10%) Take-home examination (90%) or 9,000 word research paper (90%) on a topic approved by the subject coordinator
<b>Prescribed Texts:</b>	Core subject materials will be provided free of charge to all students. Some subjects require further texts to be purchased. Details regarding any prescribed texts will be provided prior to the commencement of the subject.
