<b>Subject Overview:</b>	This subject will provide participants with the practical application of voice skills for individual development.						
<b>Learning Outcomes:</b>	<p>On completing this subject, students will:</p> <ul style="list-style-type: none"> <li>• have addressed idiosyncratic vocal and postural habits;</li> <li>• have understood and applied appropriate techniques for breathing, phonation, resonance and articulation;</li> <li>• have addressed and developed strategies for occupational health and safety issues for heightened speaking situations (e.g. teaching and performance);</li> <li>• have developed a sound, practical understanding of the relationship between the body and voice and demonstrate vocal embodiment in the moment of speaking;</li> <li>• have learned how to develop a safe vocal preparation for rehearsal and performance.</li> </ul>						

<b>Assessment:</b>	Task 1: Practical class tasks within the workshops (Equivalent to 2,000 words, 50% of total mark).Task 2: Ongoing written critical journal and post-workshop reflection (2,000 words, 50% of total mark).
