<b>Course Overview:</b>	<p><b>Please note: this course has been discontinued and will not be taking further intakes.</b></p> <p>This course is a subset of the Master of Biostatistics (see that heading for further information). On completion of the Graduate Diploma in Biostatistics, students will have attained a similar range of skills required for employment as a biostatistician as those completing the Master of Biostatistics, without the workplace project and without the scope to complete elective subjects.</p>											
<b>Learning Outcomes:</b>	<p>On completion of this course, graduates will:</p> <ul style="list-style-type: none"> <li># be able to demonstrate a broad understanding of the mathematical background, theory and application of the principles of epidemiology and biostatistical methods in health and medical research</li> <li># have acquired skills in complex statistical analyses to handle a variety of practical problems using modern statistical techniques and software</li> <li># have acquired skills in data collection and data management, including database design, quality control procedures and the ethical handling of data</li> <li># have developed skills to identify the relevant statistical issues in practical problems in medical/health settings and to propose and implement an appropriate statistical design and/or analysis methodology</li> <li># have developed skills and demonstrated ability to present statistical results in a format suitable for publication in health-related journals or professional reports</li> <li># have acquired the technical skills to be able to read methodological papers in the biostatistical literature and apply the methods described therein to practical problems</li> <li># have developed the practical and technical skills to progress to further postgraduate studies in biostatistics</li> <li># be aware of professional codes of conduct and ethical standards such as those of the Statistical Society of Australia</li> </ul>

#### Entry Requirements:

- In order to be considered for entry, applicants must have completed:
    - an undergraduate degree in a relevant discipline, such as statistics, mathematics, science, psychology, medicine, pharmacy, health sciences or economics, with a weighted average mark of at least H2B (70%); and
    - a demonstrated capacity for advanced mathematical work, indicated for example by a high level of achievement in high-school or undergraduate mathematics; and
    - a tertiary-level subject in statistics or biostatistics, or demonstrated equivalent prior knowledge of statistics at an introductory level.

Meeting these requirements does not guarantee selection.
  - In ranking applications, the Selection Committee will consider:
    - prior academic performance.
  - The Selection Committee may seek further information to clarify any aspect of an application in accordance with the **Student Application and Selection Procedure (<https://policy.unimelb.edu.au/MPF1034>)** .
  - Applicants are required to satisfy the university's English language requirements for postgraduate courses. For those applicants seeking to meet these requirements by one of the standard tests approved by the Academic Board, performance **band 6.5 (<http://about.unimelb.edu.au/academicboard/resolutions>)** is required.
- Notes
- (a) Students need to complete three specified subjects within the first 50 points of the program with a weighted average mark of at least H2B (70%) to be permitted to continue in the Postgraduate Diploma of Biostatistics or the Master of Biostatistics. The Postgraduate Certificate in Biostatistics is available as an exit award for students who complete 50 points of study but do not meet this hurdle requirement due to their subject selection or their average mark.
- (b) Successful applicants with prior cognate study at tertiary level may receive up to 50 points of advanced standing (with or without credit) towards the Postgraduate Diploma in Biostatistics or the Master of Biostatistics.
