<b>Subject Overview:</b>	This subject introduces and analyses critical concepts and terms central to debates over climate change, including risk and uncertainty, adaptation and mitigation, burden sharing, and problems and issues relating to regimes, strategies and policy instruments for addressing global warming. The subject considers the rise of climate change as a policy problem. It reviews and analyses the history of climate change policy as it has evolved nationally and internationally. It examines the interactions between national and regional climate policy, including in Australia, the United States, the European Union and China. It analyses debates and concerns that have led to the evolution of the Framework Convention on Climate Change (UNFCCC), the Kyoto Protocol, and more recent arrangements. Students will consider a range of policy instruments, including carbon taxes and emissions trading, and technologies that have been proposed or deployed to address this issue. This subject enables students to understand the evolution of a critical global environmental issue. It offers insights into technical, political, ethical and ecological issues that have framed climate change policy, particularly since 1992, and enables students to think critically about and participate in developing policy in this domain.
<b>Learning Outcomes:</b>	At the completion of this subject, students will be able to: <ul style="list-style-type: none"> <li>• Interpret the interaction between scientific, economic, normative and other influences that shape international and national climate change politics and policy development processes; and</li> <li>• Understand the key institutions and treaties that govern international and national climate change politics and policy.</li> </ul>
<b>Assessment:</b>	An essay of 1,000 words worth 20% (due mid semester) and a 4,000-word research essay worth 80% (due at the end of semester); or alternatively - subject to the coordinator's approval - a 5,000 word research essay worth 100% (due at the end of semester).

<b>Recommended Texts:</b>	Students are encouraged to read summaries of the most recent (2013/2014) reports by the IPCC (Intergovernmental Panel on Climate Change).
